

**Nature & purpose** Feature Articles in *Journal of Materials Chemistry* are review articles normally submitted by invitation. The purpose of a Feature Article is to bring the reader (a research worker in materials chemistry) up-to-date with research in a particular field, highlighting areas of special excitement and progress. Since the readership of *Journal of Materials Chemistry* is very wide-ranging it is essential that the Feature Article is easily comprehensible to a non-specialist in the field. On the other hand, the article should aim to provide an authoritative in-depth discussion of current progress and problems and should not consist of a laborious account of every paper in the area. Neither should the author concern himself with providing a comprehensive list of references; those of particular interest and significance are all that are required. Authors are encouraged to identify areas in the field where further developments are imminent or of urgent need, and any areas (such as techniques) that may be of significance to the materials chemistry community in general. No unpublished work may be presented.

**Length** Feature Articles should be 8-10 journal pages (manuscript length of 24–30 double-spaced pages), although this may vary depending on the nature of the article. Authors should include displayed material (tables and figures) as they consider appropriate.

**Abstract** A short “snappy” summary should open the article. This should be approximately 100 words long.

**Biography & photograph** A brief biography should be included, a maximum of 100 words per author. Each biography should also include one photo (black and white). There can be a maximum of 6 individual biographies per article.

**Electronic Supplementary Information (ESI):** ESI is a free facility that enables authors to enhance and increase the impact of their articles. Such data can take full advantage of the electronic medium, allowing use of full colour diagrams, 3D molecular models, movie clip files etc. Authors are encouraged to use this service to enhance their Feature Articles.

**Copyright** If an Author needs to reproduce any illustrations, tables or quotations from another source then it is the Author's responsibility to obtain written permissions from the copyright owner (normally permission is required from the publisher). A permission request form for this purpose is available at the RSC web site (<http://www.rsc.org/AboutUs/Copyright/Permissions/permissions.asp>). This should be submitted along with the manuscript. It is also the Authors' responsibility to ensure the correct acknowledgements are given in their article.

**Acceptance** At least two independent experts will referee all Feature Articles. The decision to accept (or reject) an article will be made on the basis of two agreeing reports. Suggestions for appropriate reviewers are welcomed. Authors may be required to make some alterations their manuscript before it is passed for editing.

**Reprints** Corresponding authors will receive a PDF reprint of their article and a copy of the printed issue in which their Feature Article appears. Printed reprints may be ordered on request from the Editorial Office.
