PARTICIPATION:

Accepted submissions may be presented either as individual papers or as round table propositions.

CVs FORMAT:

- Short professional CVs should be in Word format plain text, in Times New Roman font, letters size 12, line spacing: single.
- CVs should be up to 1 page and must include name, contact details and a recent photo.

PAPER DRAFTS SUBMISSION:

Paper drafts should be sent taking into account the following format:

1. Major theme of the paper should be related to at least one of the major themes given above.
2. Paper title and Author(s) name(s) should be clearly stated.
3. Paper drafts should be 2000 to 5000 words, in English including: overview, methods, results and conclusions.

PUBLICATION:

- Papers can be up to 12 pages, in Word format, in Times New Roman font, size 12, line spacing: single.
- All material must be in English.
- First page must include: author's name, organization and contact details.
- Abbreviations should be defined the first time they appear in parenthesis after the acronyms.
- All graphics must be included in the Word document.
- All pages must be numbered.
- Names of persons and places must be mentioned in complete form.

All papers and/or presentations will be included in the Electronic Conference proceedings.

ORAL PRESENTATION:

- At least one author of an accepted paper must attend to represent the paper.
- The allocated presentation time is 20 minutes.
