Speakers



Lord Neuberger is the second President of the Supreme Court. He was appointed a High Court judge in 1996 and a Lord Justice of Appeal in 2004. In 2007 he was made a Lord of Appeal in Ordinary and created a life peer as Baron Neuberger of Abbotsbury in the County of Dorset.



Elwen Evans QC is a leading criminal silk. She chooses to live and practise in Wales. She appears for both prosecution and defence in serious, complex and high profile cases including murder, serious sexual offences and fraud. Her style is described as 'determined and formidable' by those instructing her.



Jason Tucker is a solicitor and Reader-in-Law, specialising in criminal litigation and children proceedings. In addition, Jason is Deputy Director of the Cardiff University Law School Bond Solon Expert Witness Certificate. Away from the University, he sits as a magistrate and deputy district tribunal judge.



Neil Dooley is a partner at Steptoe & Johnson specialising in contentious commercial work, particularly in respect of frauds on financial institutions (Otkritie, Dubai Islamic Bank, BCCI, Barings) and freezing order applications. He is experienced in heavyweight commercial litigation, insolvency and fraud.
